10 Pursuant to Notice of Hearing Number 01-0022-PHR ("Notice") this matter came before the
11 Arizona State Board of Pharmacy ("Board") on January 10, 2002.

12 Gerald G. Ritt, president, presided with members Susan V. Ford, Dennis McAllister, Paul
13 Draugalis, William Jones, Daniel Ketcherside and Eugene Drake in attendance.

14 The State was represented by the Office of the Attorney General, Victoria Martin, Assistant
15 Attorney General, Licensing and Enforcement Section.

16 The respondent, JESSE I. KLEINHESSELINK was not present and not represented by counsel.

17 **FINDINGS OF FACT**

18 **I**

19 1. JESSE I. KLEINHESSELINK is the holder of Pharmacist License Number 10867 issued by
20 the Arizona State Board of Pharmacy which permits the holder to practice pharmacy in the State of
21 Arizona.

22 2. The evidence presented in this matter sustained the factual allegations in section IV of the
23 Notice. The Board finds that:

24 JESSE I. KLEINHESSELINK has violated A.R.S. § 32-1927(A)(5) and A.R.S. § 32-1927(B)(2),
25 to wit:

26 (A)(5) The licensee is addicted to the use of alcohol or drugs to such a degree as to render the
licensee unfit in the opinion of the Board to practice the profession of pharmacy.

1 (B)(2) The licensee is found by the board, or is convicted in a federal or state court, of having
2 violated federal or state laws or administrative rules pertaining to marijuana, prescription-only
3 drugs, narcotics, dangerous drugs or controlled substances.

4 **CONCLUSIONS OF LAW**

5 **II**

6 1. The Board concludes that it has jurisdiction in this Matter pursuant to A.R.S. § 32-1927
7 (A)(5) and 32-1927(B)(2).

8 2. The Board concludes that JESSE I. KLEINHESSELINK violated A.R.S. § 32-1927(A)(5) and
9 A.R.S. § 32-1927(B)(2).

10 **ORDER**

11 **III**

12 The Pharmacist License Number 10867 issued to JESSE I. KLEINHESSELINK is hereby
13 revoked effective immediately.

14 **RIGHT TO REHEARING**

15 **IV**

16 JESSE I. KLEINHESSELINK is hereby notified that he has the right to petition this Board for
17 a rehearing or review of this decision within thirty (30) days after the receipt of this Order pursuant to
18 A.A.C. R4-23-109 (D). A request for a rehearing or review of this decision shall be in writing and satisfy
19 the prerequisites in A.R.S. R4-23-109(D). Pursuant to A.R.S. § 42-1092.09(B), failure to file a motion
20 for rehearing or review has the effect of prohibiting judicial review of this Order.
