9 Pursuant to the foregoing Consent to Entry of Order, the evidence and records compiled and
10 contained in the file for PATRICK A SHARP and for good cause appearing, the Board on this 2nd day of
11 May, 2002 enters the following Findings of Fact, Conclusions of Law and Board Order in the Matter of
12 Notice of Hearing Number 02-0006-PHR ("Notice").

13 **FINDINGS OF FACT**

14 **I**

15 1. PATRICK A SHARP is the holder of Pharmacist License Number 6155 issued by the Arizona
16 State Board of Pharmacy which permits the holder to practice pharmacy in the State of Arizona.

17 2. The evidence presented in this matter sustained the factual allegations in paragraphs one (1)
18 through eleven (11) in section IV of the Notice. The Board finds that:

19 PATRICK A SHARP has violated A.R.S. § 32-1927(A)(10), A.R.S. § 32-1927(B)(2), A.R.S. §
20 36-2525(D), A.R.S. § 32-1968(A), and 21 C.F.R. § 1306.21(a) to wit:

21 the dispensing of prescription-only drugs and Class III and IV Controlled Substances as listed in
22 the Notice of Hearing Number 02-0006-PHR without valid prescriptions.

23 **CONCLUSIONS OF LAW**

24 **II**

25 1. The Board concludes that it has jurisdiction in this Matter pursuant to A.R.S. § 32-1927
26 (A)(10) and 32-1927(B)(2).

1 7. PATRICK A SHARP shall obey all federal and state laws and rules governing the practice of
2 pharmacy.

3 8. PATRICK A SHARP shall bear the responsibility for the release of information forms and
4 reports required by this Order.

5 9. PATRICK A SHARP shall "hold harmless" the provider of any required reports to the Board
6 of Pharmacy.

7 10. PATRICK A SHARP shall appear before the Arizona State Board of Pharmacy on or after
8 May 2nd, 2007, to request that the probation imposed by this Order be terminated.

9 11. If PATRICK A SHARP violates this Order in any way or fails to fulfill the requirements of
10 this Order, the Board, after giving PATRICK A SHARP notice and the opportunity to be heard, may
11 revoke, suspend or take other disciplinary action against PATRICK A SHARP. The only issue at such a
12 hearing shall be whether or not this Order has been violated.
