This matter came before the Arizona State Board of Pharmacy for hearing on the 2nd day of June, 1988, pursuant to Complaint and Notice of hearing No. 88-5-H (hereinafter referred to as "Complaint"), attached to and made a part of this order. Danny Jacobs president, presided, with Norma McConnell, vice president, and members Michael Noel, Sumner Brooks, Edward Saba, and Martha Barron in attendance and participating therein.

The State was not represented by legal counsel. The respondent, JAIME CASILLAS was present but was not represented by counsel.

The Board, after consideration of the evidence and testimony presented, hereby makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

I

JAIME CASILLAS is a pharmacist holding Certificate of Registration No. 3261 issued by the Board under A.R.S. § 32-1922.

II

Sufficient evidence was presented, including testimony of the Deputy Director of the Board of Pharmacy and stipulations of JAIME CASILLAS to sustain the charges contained in the complaint.

CONCLUSIONS OF LAW

III

That the Findings of Fact set forth herein above constitute sufficient evidence to find that JAIME CASILLAS is in violation of those State and Federal Laws, Rules and Regulations contained in paragraph IV of the complaint.

IV

The above described violations constitute grounds for discipline pursuant to A.R.S. § 32-1927.B.

ORDER

V

In view of the above Findings of Fact and Conclusions of Law the Board hereby issues the following Order:


1. That the Certificate of Registration No. 3261 issued to JAIME CASILLAS be suspended for a period of six (6) months, effective June 10, 1988 terminating December 10, 1988.
2. That the suspension of Certificate of Registration No.3261 issued to JAIME CASILLAS be stayed.
3. That JAIME CASILLAS, holder of Certificate of Registraton No. 3261 be assessed a civil penalty of \$250.00. Such penalty is due and payable on or before July 10, 1988.
4. If at any time during the dates of July 10, 1988 and December 10, 1988 JAIME CASILLAS is found after a hearing to be in violation of any Federal or State Law, Rule or Regulation promulgated pursuant thereto, regarding the practice of pharmacy and/or the dispensing of drugs, or any other condition imposed by this order, the Certificate of Registration No. 3261 may be revoked upon motion carried by the majority of the Board quorum.

JAIME CASILLAS is hereby notified he has the right to petition this Board for a rehearing with ten (10) days after receipt of this Order pursuant to the provisions of Administrative Rule R4-23-109.
