Pursuant to the foregoing Consent to Entry of Order, the evidence and records compiled and contained in the file for STEVEN MICHAEL GENRICH and for good cause appearing, the Board on this 27th day of March, 1991 enters the following Finding of Fact, Conclusions of Law and Board Order in the Matter of 91-06-H.

FINDINGS OF FACT

I

1. STEVEN MICHAEL GENRICH is the holder of Certificate of Registration Number 7861 issued by the Arizona State Board of Pharmacy which permits the holder to practice pharmacy in the State of Arizona.
2. That on the 11th day of March, 1991 STEVEN MICHAEL GENRICH did enter into a Consent to Entry of Order with the Arizona State Board of Pharmacy regarding the factual allegations contained in Notice of Hearing Number 91-06-H.
3. That STEVEN MICHAEL GENRICH is found to have violated A.R.S. § 32-1963.01, 32-1968, 32-1927.B, 36-2525, 36-2523, C.F.R. § 1306.11, 1306.05,

1 and 1304.03 to wit: dispensing or causing to be dispensed Schedule II
2 Controlled Substances without a proper prescription order, failure to maintain
3 complete and accurate records on the receipt and disposal of Class II Controlled
4 Substances, illegal substitution, failure to record patient address, physician
5 address and DEA number of the physician on the prescription order and further
6 the use of of illegal prescription order blanks.

7 CONCLUSIONS OF LAW

9 1. The Board concludes that it has jurisdiction in this Matter pursuant to
10 A.R.S. § 32-1927.

11 2. The Board concludes that STEVEN MICHAEL GENRICH did violate A.R.S. §
12 32-1963.01, 32-1927(B)(1), 32-1968, 36-2525, 36-2523, C.F.R. § 1306.11, 1306.05,
13 and 1304.03 to wit: dispensing or causing to be dispensed Schedule II Controlled
14 Substances without a proper prescription order, failure to maintain complete and
15 accurate records on the receipt and disposal of Class II Controlled Substances,
16 failure to obtain proper authorization for generic substitution, failure to
17 record patient address, physician address and Drug Enforcement Administration
18 (DEA) number of the physician on the prescription order and further the use of
19 improper prescription order blanks.

20 3. The Board further concludes that STEVEN MICHAEL GENRICH is in violation
21 of A.R.S. § 32-1927(B)(1)&(2).

24 The Certificate of Registration 7861 issued to STEVEN MICHAEL GENRICH is
25 hereby placed on probation commencing April 15, 1991 for a period of two (2)
26 years ending after April 14, 1993, with the following conditions:

1. Respondent shall pay a civil penalty of fifteen hundred dollars (\$1500.00) due and payable, in three (3) equal installments of five hundred dollars (\$500.00) each, on June 15, September 15, and December 15, 1991.

2. Respondent shall not be a preceptor during the time of probation commencing April 15, 1991 and ending after April 14, 1993.

3. Respondent shall take and pass the jurisprudence exam with a score of 90% or better on or before June 1, 1991.

4. Respondent shall pay all fees and complete all Continuing Education requirements throughout probation period to maintain Certificate of Registration 7861.

5. Respondent shall obey all the laws and rules governing the practice of pharmacy.


6. Respondent shall appear before the Arizona State Board of Pharmacy after April 14, 1993 to show cause why the probation imposed on Certificate of Registration 7861 should be removed.

7. If the Respondent violates this Order in any way or fails to fulfill the requirements of this Order, the Board, after giving the Respondent Notice and the opportunity to be heard, may revoke, suspend or take other disciplinary action against the Respondent.
