This Matter came before the Arizona State Board of Pharmacy on the 10th day of September, 1992 pursuant to a letter of request by the Respondent, petitioning the Arizona State Board of Pharmacy to reconsider the Order issued in the Matter of 92-01-H. Daniel J. Jacob, president presided with Kim Roberson, vice-president and members Linda Tansik, and Michael Noel, John Harrington and Kathryn L. Kalsman in attendance and participating therein.

GEORGE O. FRANKLIN, requested that Certificate of Registration number 2402 be placed on "inactive status" indefinitely. GEORGE O. FRANKLIN further offered to surrender pharmacy permit number 1160, issued to Franklin Pharmacy at 524 E. Grand Ave. #F in Nogales, Arizona, on or before September 30, 1992.

GEORGE O. FRANKLIN petitioned the Board for the issuance of a patent and proprietary permit for Franklin's at 524 E. Grand Ave. #F in Nogales, Arizona.

Further GEORGE O. FRANKLIN requested the Board vacate the Sanctions imposed in the Matter of 92-01-H.

After deliberation the letter of petition dated August 7, 1992 by GEORGE O. FRANKLIN was accepted and the Board unanimously agreed

1 to vacate the Order of 92-01-H. Further, GEORGE O. FRANKLIN shall
2 be required to appear before the Arizona State Board of Pharmacy to
3 show cause why the "inactive status" on Certificate of Registration
4 2402 should be altered. The Board may at this time impose
5 conditions (if any) relevant to the Respondent's ability to
6 actively practice the profession of pharmacy.


