This Matter came before the Arizona State Board of Pharmacy on the 19th day of January, 1995 pursuant to a request by the Respondent, to show cause why the suspension imposed on Certificate of Registration Number 7899 should be stayed and probation be imposed continuing to at least to the 1st day of December, 1999. Perry D. Don, president presided, with Gerald Ritt, vice-president and members Linda Tansik, Michael Noel, John Harrington, Daniel Jacob and Charles Cordell in attendance and participating therein.

The Board heard testimony on the Respondent's compliance with the Pharmacists Assisting Pharmacists of Arizona drug abuse recovery program. After deliberation on the testimony presented the Board unanimously agreed to stay the suspension and impose probation to at least the 1st day of December, 1999. The remainder of the Order remains in effect.
